Dock Update: Trevor

All approvals by stakeholders and regulators have been conditionally approved. Conditions are essentially to provide them details of the planned work.

The financial grant is still under review.

John found another option to receive financial support. It is the City of Saskatoon Sport Projects grant which would contribute to a maximum amount of \$10,000. The application deadline is February 15, 2022.

Darryl mentioned the National Sport Trust Foundation might be able to hold the money to be a tax donation.

We can update our zone 4 membership to see If anyone wants to make donations directed to the dock.

John asked about Jeux Canada games funding.

Fundraising Committee: Franny

Volunteers from each club are working towards reducing the \$120,000 sum that represents the 25% the clubs are responsible for.

We had 2 members join and have been engaged. The question came up if it was reasonable to share our membership list with them to contact.

It seemed like there was ideas out of the meetings but no support.

We will continue to support the fundraising initiative but are looking for more work from the other clubs.

CKS Update: Kathleen

Three executives have resigned from the positions of President, Marketing and Recreation.

Marcel has signed the compensation letter for his termination.

Jessica Riley is now being funded as PDD and Head coach of Yorkton.

The bylaw change progress slowed over this period and we are starting to turn our attention back to making these changes.

Looking into strategic plan dates. Prairie Consulting responded right away and members of our club with 25 years of experience. Had an initial meeting through zoom and are only asking for 5 years of free memberships for 3 people.

John is asking if someone can help him with this process if we want to move forward with something this summer. General response was it could wait.
