Urgent meeting called in response to COVID-19 pandemic:

As the province has called a State of Emergency in response to try and flatten the curve of transmission of COVID-19, we had much discussion about the closure of the Saskatoon Canoe Club.

Some of the issues discussed were as follows:

- * Public gathering places have been shut down like Leisure Centres, gyms etc. The province has asked that everyone practice social distancing. We currently don't have measures in place to ensure our current members who have access to the club respect the 2m distance recommended for social distancing. Nor do we have sanitation equipment and policies in place at this time.
- * The ever changing nature of the COVID-19 pandemic is changing hour by hour as more information comes to light. More clarity is required for us to consider operating in a fashion that is safe for our members, community and in compliance with the Government of Saskatchewan. Our club does not want to inadvertently contribute to the spread of COVID-19.
- * We understand that this situation may affect our operation for the summer and it is a possibility that we won't hire summer employees as planned. We may have to cancel courses planned for the summer. All affected will be notified of potential changes.
- * We realize that there are enormous economic implications for many during this time and have decided we will refund membership fees to those who request it during our closure.

*We acknowledge that the Saskatoon Canoe Club provides recreation to our members that is very important for health and well being and that there will be some harm for our members caused by our temporary closure. We hope it won't be long and we will continually be re-evaluating and seeking out information to reopen safely.
