This time last year we had 1265 club members. Our membership is down a considerable amount. We don't plan to do anything about decreased membership at this time.

Eithan, John, Lauren and Kathleen did an inspection of all the Recreation canoes and Kayaks to document repairs needed and condition of the boats.

A hard wired, permanent internet connection was installed in the boathouse. This will be seasonally connected and disconnected.

We were denied our application for the Summer Jobs Grant. CKS submitted the grant application on our behalf. We will consider submitting the applications ourselves next year so that we can provide more detail.

Washrooms will be opened sometime this week.

In accordance with the Re-Open Saskatchewan plan we will now be allowed to host group activities not exceeding 30 people. As such, we will resume group Recreation and group Marathon paddles. Details on how these will be structured and organized need to be worked out.

We've decided not to host any paddling lessons this year due to COVID-19.
