Staff Update

We'd like to thank both Bryan and Shay for their help this summer as our Boat House Supervisor employees. It was really appreciated by our board and members. Bryan has finished up his hours for the summer and Shay may pick up a few more hours in September.

We requested both Bryan and Shay to complete a year-end report. Shay has submitted a report. The following are report highlights:

- Shay felt that overall things went very well this summer, but there continues to be a problem with non-members using SCC equipment.
- Digital sign-in may eliminate some of the non-member usage as well be useful for data collection on boat usage.
- Video surveillance
- Permanent internet connection would be necessary for the above options.
- Limit hours of use to Rec members when there is staff present. Would require constant staffing.
- We could offer a bring a friend option for \$15-\$30 as a drop-in fee. Would have to come with a member and sign a waver. This would be available during staff hours.
- Temporarily suspend memberships for misusing equipment or bringing non-members.
- Boat Spec Poster to help with basic boat selection.
- Trip leader checklist to ensure the prospective trip leader has the prerequisite skills to plan a trip.
- · Replace and improve some of the signage.
- Emergency Action Plan
- Much of Shay's time was spent answering emails and interacting with members so was not able to digitize sign-out records.

Richard has left SCC membership registration open till Sept 30, 2019.

There are 1630 members. 1295 are Recreation, 30 Marathon members, 65 dual and 240 children.

Action: Nicole will send a survey out to members in November similar to last year. May add a couple questions regarding how members felt about having staff on site.

Discussion about the idea of photo Id membership cards issued to members to use to sign out boats.

Richard will work on electronic sign out for next year.

John is still looking into insurance implications of children signed up with members who aren't their legal guardians for example grandparents.

Should we ask for an emergency contact number on next year's registration? Think this would be a good idea. This would have been useful in a couple of past events.

Recreation Director: Eithan

Ladies night paddle was a success. Another is being organized for September 17, 2019. Poplar Bluffs to Saskatoon. Leaving boathouse at 4:30pm.

Eithan has been working with Shay to send out a half dozen emails to members that have been caught bringing non-members and using SCC equipment.

Much discussion regarding how this should be handled and if we should revoke memberships for misuse. Agree that it is too late in the season to bother this year, but will discuss further our future protocol for the upcoming season.

Equipment Manager-Canoe: John

John has been working on digitizing the sign out data. It is extremely time consuming. Agree that some sort of electronic sign out would be valuable for next season. This information is useful to track which boats are most popular etc.

John is still in the process of acquiring quotes for a canoe trailer.

Considering the sale of a couple canoes and replacing with a couple of lighter canoes.

Since the vast majority of boat usage are kayaks (approximately %80), we could move a couple of heavier seldom used canoes to offsite storage and use the space in the boathouse to house more kayaks.

Action: John will draft a plan to sell and purchase canoes.

Equipment Manager-Kayak: Kathleen

Shay submitted a report on damaged kayaks K64, K65, K14, K17, K72, K70T, K13T. Based on the age of the boat, damage and difficulty of repair it is proposed that we sell and replace the following kayaks:

K13T, 20ft, purchased in 2011
K14, 14ft, purchases in 2011
K64, 14ft, purchased 2016
K72, 14ft, purchased in 2017
```

Suggested Replacement Kayaks:

Total with GST & PST = \$8230.65

```
2 X Delta, 14ft with rudder = $3640.00 ($1820 ea)

Delta Tandem 17.5ft with rudder = $2480.00

Delta 12ft = $1295.00
```

Delta will reinforce the thigh braces and trim the thigh back to make it easier to enter/exit. Reinforcement will be added where the cord for the backrest comes through the cockpit. Delta is also looking into an alternate mechanism to the nylon jam cleat for the seat back adjustments.
