 - Members at Large
 - Date for AGM April 19th usually do this at a library, though last years have done online, often have a little food (pizza), We will look into Lawson heights library. Usually start at 6:00.
 - Off season work we will further define positions on executive -we have some descriptions and a task calendar, tells who should do what at what time each year, Garnet will send out something

Membership (Corwyn)

We spoke to CKS to see what doing for registrations at provincial level, Ramp, it is probably worth looking at moving towards using the Ramp system, may not have it going for January. It will automatically import reports. Zone 4 is not user friendly. We could switch over any time.

- Marathon (Edith)
 - Issue with CKS, they gave us a bill. There is some confusion about how marathon pays dues, owing \$1,300. Fees for CKS will remain at \$20, but don't include national membership.
 - Need to increase membership fee for Marathon
 - Are considering having a grant program where we help people who cannot afford the membership can apply for assistance.
 - We could use a sliding scale and let people self select what they pay.

Motion – Set aside \$2000 for supplementing membership rates for those that need assistance.

At the AGM we intend to increase membership costs for marathon member to \$75 and Dual to \$90, and Recreation will stay the same for the 2024 paddling season
